FloWorks Software License Agreement

Version: 06-May-2025

This software license agreement ("Agreement") is between Talumis B.V., a Dutch corporation ("Talumis") and you ("Client") (collectively the "Parties"). Use of the accompanying software indicates your acceptance of these terms. In this Agreement, the capitalized term "Software" means the FloWorks module that was downloaded, received, or included on the media provided with this Agreement.

FloWorks is built on the FlexSim simulation platform, owned by FlexSim Software Products, Inc., a Utah corporation ("FlexSim"). The name "FlexSim" will be used where FloWorks uses the services of FlexSim Software Products, Inc., an AutoDesk Inc. company.

The Parties agree as follows:

1. **Ownership.** The Software and any accompanying documentation are owned by Talumis or its licensors and are protected under Dutch. copyright laws and international treaty provisions, as well as other intellectual property laws and treaties. Talumis or its licensors, are and shall remain the owners of all intellectual property rights in the Software, and all copies, modifications and merged portions thereof. The Software is licensed to you on a non-exclusive, non-assignable, non-transferable basis and not sold. Models and libraries created by you using the Software are your intellectual property and are owned exclusively by you.

2. Grant of License.

- 1. The Software and accompanying documentation are being licensed to you, meaning you have the right to use the Software only in accordance with this Agreement.
- 2. If you paid for a standalone (or client-activatable) license type, Talumis grants you the right to install the Software on any number of computers provided that at any time the number of activated licenses does not exceed the number of licenses for which you have paid.
- 3. If you have paid for a network (or server-concurrent) license type, Talumis grants you the right to install the license manager on one computer server, and the Software on any or all client computers connected to the computer server, provided that at any time the number of concurrently checked-out licenses does not exceed the number of licenses for which you have paid.
- 3. **Scope of Use.** You may not sublicense or lease the Software or any of the accompanying documentation to any other person or organization. You may use the Software only for your own internal business purposes or services you provide to other organizations.
- 4. **Non-permitted Uses.** Without the express permission of Talumis, you may not (a) use, copy, modify, alter, or transfer, electronically or otherwise, the Software or any of the accompanying documentation except as expressly permitted in this

Agreement, or (b) translate, reverse program, disassemble, decompile or otherwise reverse engineer the Software.

5. **Transfer of License.** You may not transfer the license to use the Software to another person or entity, without express permission from Talumis. Any transfer must include all updates and all accessible prior versions of the Software, and all copies of the Software must be removed from your computer (or computers) and delivered to the transferee or destroyed.

6. Minimum end user terms.

- Internet access is generally required to activate licenses from FlexSim's master license server. After such activation is accomplished, licenses remain on the computer to which they were activated, regardless of Internet connectivity.
- In order to activate or return a license over the Internet, the Software gathers and transmits certain hardware, software, and license information to <u>license.flexsim.com</u> and <u>www.flexsim.com</u>. This information is stored using AES256 encryption.
- 3. Licenses may be revoked by Talumis in the event of notification to Talumis, by the end-user or local FlexSim representative or the Software itself, that such licenses are lost, expired, timed out, stolen, or broken.
- 8. **Term.** This license is effective from your date of download or purchase and shall remain in force until terminated. You may terminate the license and this License Agreement at any time by destroying the Software and the accompanying documentation, together with all copies in any form.
- 9. **Export Controls.** Certain uses of the Software by you may be subject to restrictions under U.S. regulations relating to exports and ultimate end uses of computer

software. You agree to fully comply with all applicable U.S. laws and regulations, including but not limited to the Export Administration Act of 1979 as amended from time to time and any regulations promulgated there under.

10. **U.S. Government Restricted Rights.** If you are acquiring the Software on behalf of any unit or agency of the United States Government, the following provision applies: It is acknowledged that the Software and the documentation were developed at private expense and that no part is in the public domain and that the Software and documentation are provided with restricted rights. - Talumis warrants to you that the Software will perform substantially in accordance with the accompanying documentation. Talumis does not warrant that the Software is error-free or that the Software will operate without interruption. This Limited Warranty extends for ninety (90) days from the date the Software is paid for or first used, whichever occurs first.
- 2. This Limited Warranty does not apply to any Software that has been altered, damaged, abused, misapplied, or used other than in accordance with this license and any instructions included on the Software and the accompanying documentation.
- 3. Talumis's entire liability and your exclusive remedy under this Limited Warranty shall be the repair or replacement of any Software that fails to conform to this Limited Warranty or, at Talumis's option, return of the license fees paid for the Software. Talumis shall have no liability under this Limited Warranty unless the Software is returned to Talumis or its authorized representative within the warranty period. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.
- 4. THIS LIMITED WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES NOT EXPRESSLY SET FORTH HEREIN, WHETHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR WARRANTIES ARISING FROM USAGE OF TRADE OR COURSE OF DEALING.

12. Limitation of Liability.

 EXCEPT WITH RESPECT TO TALUMIS'S INDEMNIFICATION OBLIGATIONS SET FORTH IN SECTION 11, IN NO EVENT SHALL EITHER PARTY BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OF REVENUE OR PROFIT, LOST OR DAMAGED DATA OR OTHER COMMERCIAL OR ECONOMIC LOSS, EVEN IF THE PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR THEY ARE FORESEEABLE.

- 2. EXCEPT WITH RESPECT TO TALUMIS'S INDEMNIFICATION OBLIGATIONS SET FORTH IN SECTION 11, IN NO EVENT SHALL EITHER PARTY'S MAXIMUM AGGREGATE LIABILITY FOR DAMAGES, LOSSES AND CAUSES OF ACTION, WHETHER IN CONTRACT, TORT (INCLUDING, BUT NOT LIMITED TO, NEGLIGENCE), OR OTHERWISE EXCEED THE AGGREGATE AMOUNT PAID OR PAYABLE BY CUSTOMER TO TALUMIS FOR THE LICENSE FEES.
- 13. Entire Agreement. - 14. **Amendment and Modification.** No modification or amendment of this Agreement shall be binding unless executed in writing by both Parties. No waiver shall be effective unless it is in writing and signed by the Party against whom enforcement is sought.
- 15. **Assignment.** This Agreement may not be assigned by either Party without the prior written consent of the other.
- 16. Choice of Law/Forum. This Agreement shall be governed by and construed in accordance with Dutch law, without regard to its rules regarding conflicts of law. Each of the Parties consents to the jurisdiction of the courts located in the Netherlands with respect to all matters relating to this Agreement and agrees that all litigation relating to this Agreement shall take place in courts located in the Netherlands.
- 17. **Handwritten Changes.** Any handwritten changes made to this Agreement must be initialed by all Parties in order to be binding on the Parties. The Parties have had the opportunity to discuss this Agreement with their legal advisors.
